Definition

Risks is the [effect](#) of uncertainty on [objectives](#).

Notes

- Risk is usually expressed in terms of
 - Risk sources
 - Potential events
 - Their consequences
 - Their likelihood

Example

[Objective](#) is that 95% of the telephone numbers in de customer file are [valid](#). However, the front-end application doesn't check the [format](#) of the telephone number. Therefore, it is uncertain if the customer always properly complete their telephone number. The [effect](#) of this uncertainty can be, that the [objective](#) will not be met.
